The following is a brief summary of the program for assisting senior citizens to pay school taxes on the home that they own and occupy that was adopted by the Board of Education on October 23, 2023

- a. EFFECTIVE DATE: School Real Estate Taxes issued August 1, 2023, and <u>PAID</u> by December 31, 2023
- b. ELIGIBILITY: One or more of the following (A, B, C):
 - 1. A) One member of the household must be age 65 or over on December 31, 2023.
 - B) Individual is a widow or widower and age 50 or over on December 31, 2023.
 - C) Individual is permanently disabled and age 18 or over on December 31, 2023
 - 2. INCOME: \$45,000 or less.
 - 3. AMOUNT OF REBATE: based on income, as follows:

- 4. MAXIMUM REBATE cannot exceed \$1,000.00, on homestead only.

- c. FILING LATE APPLICATIONS WILL NOT BE ACCEPTED NO EXCEPTIONS
 - 1. WHEN TO FILE: August 1, 2024 December 31, 2024
 Applications postmarked after December 31. 2024 will be denied. Applications that are received incomplete will not be processed.
 - 2. WHERE TO FILE: <u>ONLY ACCEPTING APPLICATIONS BY MAIL, THERE WILL BE NO OFFICE HOURS OR DROP OFF THIS YEAR.</u>
- d. A COPY OF THE ENTIRE RESOLUTION CAN BE OBTAINED UPON REQUEST.
