The following is a brief summary of the program for assisting senior citizens to pay school taxes on the home that they own and occupy that was adopted by the Board of Education on March 16, 2020

- a. EFFECTIVE DATE: School Real Estate Taxes issued August 1, 2022 and <u>PAID</u> by December 31, 2022
- b. ELIGIBILITY: One or more of the following (A, B, C):
  - 1. A) One member of the household must be age 65 or over on December 31, 2022;
    - B) Individual is a widow or widower and age 50 or over on December 31, 2022;
    - C) Individual is permanently disabled and age 18 or over on December 31, 2022
  - 2. INCOME: \$35,000 or less.
  - 3. AMOUNT OF REBATE: based on income, as follows:

\$ 0 - \$ 8,000	\$650.00
\$ 8,001 - \$15,000	\$500.00
\$15,001 - \$18,000	\$300.00
\$18,001 - \$35,000	\$250.00
